## THINKING ABOUT SOLAR **ENERGY FOR YOUR HOME?**

Here are seven helpful tips to get you started.



- 2. EFFICIENCY FIRST. Reducing the amount of energy you use will reduce the size of solar array you need. For ideas and tools, visit energystar.gov or energy.gov/save. Our utility offers rebates on energy efficient equipment. Learn more at: brightenergysolutions.com.
- 3. LEARN ALP'S REQUIREMENTS. Your solar system needs to interconnect with ALP's system to ensure you have electricity when your solar array is not producing enough power. Learn about interconnection requirements ALP has in place to keep the electric grid safe and reliable at: alputilities.com/solar.
- 4. ESTIMATE YOUR SIZE. Using past electric bills, estimate your monthly and annual energy usage in kilowatt-hours (kWh). Determine the size of system you want to install. Here is a free online tool to estimate how much energy your system will generate: pvwatts.nrel.gov.

- 5. CHOOSE A REPUTABLE VENDOR. If you proceed, choose a reputable vendor to help you understand the sizing, equipment and economics of the array. Ask for references and check online reviews. To find a certified professional, visit the North American Board of Certified Energy Practitioners' website: directories.nabcep.org. Review your proposal to make sure assumptions about future electric rates and potential revenue from selling excess generation are accurate.
- UNDERSTAND THE FINANCIAL IMPACT. Estimate the cost of your solar system over the life of the panels, including maintenance. Solar production will reduce your energy purchases from ALP with energy produced above your household consumption credited by ALP Utilities at our avoided cost rate (currently \$.0455 / kWh.)
  - Compare your average monthly kWh usage to the estimated monthly generation of your solar array to get an idea of how your utility bill might be impacted. A solar system might reduce some parts of your bill, but not others.
- 7. BEGIN THE INTERCONNECTION PROCESS. You can find the process outline on our website alputilities.com/solar. Talk to ALP staff if you have any questions about the interconnection process.

#### SYSTEM WIDE ELECTRIC AND WATER METER CHANGEOUT

A system wide meter changeout for all electric and water customers will begin mid-fall. ALP has contracted with Allegiant Utility Services to deploy and install the new meters. As we get closer to when crews will be in your neighborhood doing water meter changeouts, please look for additional communications to come from Allegiant and ALP. All water meters are located inside the home and an appointment will need to be scheduled with Allegiant to complete the changeout. Allegiant

# ANNUAL MINNESOTA COLD WEATHER RULE NOTICE



The Minnesota Cold Weather Rule was established to protect people who may have trouble paying their bills in winter. The Cold Weather Rule does not prohibit all winter disconnections. If you receive a Notice of Disconnection this winter, you must act immediately.

The Minnesota Cold Weather Rule applies from October 1 - April 30. The rule, established by the Minnesota Public Utilities Commission, means that your utility cannot disconnect your residential electric service during the winter if you meet ALL the following requirements:

- 1. The disconnection would affect your primary heat source
- 2. You have declared inability to pay, on forms provided by the utility;
- 3. Your household income is less than 50% of the state median income level, as documented to the utility.

## 4. <u>You enter into and make timely payments under a mutually acceptable payment schedule with ALP</u> Utilities.

If you have trouble paying your utility bill, local agencies may be able to provide payment assistance. Energy assistance funds can be used to pay only the electric portion of your utility bill. If you experience trouble paying your utility bill, contact ALP at 320-763-6501. We will work with you to set up an acceptable payment schedule.
